## Fundraising

In 2021/2022, the Fundraising Committee raised money both by applying for corporate grants and donations and by selling crocheted items and donated yarn.

Corporate and Foundation funding totalled almost \$13,000! Our major donors for 2021/2022 were:

- Finch Auto through their matching campaign (\$3046);
- The Wilf and Jean Bell Foundation (\$2815);
- TD Canada Trust (\$2500);
- Bayer via the Farmers Grow draw (\$2500); and
- Walmart (\$1000).

Two of our members were able to obtain donations from their employers, Canada Life (\$500) and Great Canadian Gaming (\$500) - thanks to both these members for taking the time to submit the applications.

We raised nearly \$5000 through sales. At the London Knights Teddy Bear Toss in December, we made \$1860 by selling our dressed bears before the game and in June we made \$1184 by selling our items at the Wortley Village Gathering on the Green event. Other miscellaneous sales to members and friends totalled \$735. We also raised \$1409 through online sales of non-acrylic yarn and other donated items.

Many thanks to the Fundraising Committee and everyone else who contributed to another successful year for fundraising.

## Donations

Thank you to members, families and friends who made monetary and yarn donations; also to The Focal Point Group (our landlord at Waterloo St.) for continuing a \$300.00 monthly donation to the Club.

## Expenses

One major expense of the Club is yarn cost. Total spent \$7,691.72.

A continuing expense for us as a result of the pandemic and the launch of the Clubhouse is rent. The Club pays \$700.00 plus HST monthly for the rented space at 111 Waterloo Street. (\$9,492 for the year)

# **Financial status**

Total income for the year \$33,072; total expense for the year \$21,677; net for the year \$11,395; and current bank balance \$39,234.

The complete financial report is attached; a limited number of copies will be available for review at the meetings. Members will be asked to vote on the acceptance of the financial report at each meeting.

# **Blanket Donations**

1036 (16,293) blankets were donated to 30 agencies; 12 (478) silent auction blankets were donated to 6 agencies and 354 (2989) pet blankets were delivered to 5 agencies.
